#### **Definitions of Salon Categories:**

A: Landscapes and/or Waterscapes. Hand of man should appear minimally in these images. B: **People**. Any aspect of human activity featuring one or more persons. This category includes portraits of people. C: Fauna. Includes both wild and domesticated fauna. D: Flora. Includes both wild and domesticated flora. E. Architecture. Can be an image showing small architectural details up to a large number of structures, including buildings and bridges and other manmade structures. F: General. Anything. G: Contemporary/Creative. Images should have a contemporary or creative feeling. This is the primary category for strongly manipulated, very drastically

altered digital images, although such images may also be entered in F, General.

The Club hosted its ninth consecutive annual Best in Show Print Competition at Lincoln Square Village from February 20 through February 28. Approximately 15 persons, including about 12 from the Club, worked on

This year 203 photographers entered 513 prints. Cash and gift certificates worth over \$2100 were awarded to the contestants receiving a ribbon.





## Champaign County Camera Club 2010 Salon Rules - *Print Competition*

- 1. Your competition number is the same as your monthly competition number.
- 2. Competition is open only to members who have been enrolled in the Club and have paid their dues at least one month before the Salon.
- 3. This year we have just two very broad categories: A. Small prints. B. Large prints. A member may submit no more than a total of 10 (ten) prints across the two categories, with a maximum of 6 prints in either print category. A print is small if it is 8.5 x12 or smaller. It is large if it exceeds 8.5 x12 in any dimension.
- 4. Small prints should be mounted on 11 x 14 mounts. Large prints should be mounted on 16 x 20 mounts. We allow a small amount of tolerance in the event that the print would look better on a mount not quite the two basic sizes. Please note that CICCA requires 11 x 14 or 16 x 20 mounts and prints are disqualified if the mounts vary more than fractions of inches from these sizes (so if you are intending to submit the print to either of the CICCA Salons, you need to adhere to the size restrictions exactly).
- 5. The following information must be given on the back of the print mount near the upper left hand corner:
  - A. Maker's name and competition number.
  - B. Category letter and print number.
  - C. Title of print.

*Note:* The maker's name must not appear on the front of the picture mount.

- 6. The entry blank should be filled out and submitted with the prints. Number prints consecutively in each category beginning with No. 1. <u>Use separate entry blanks for small and large prints</u>.
- 7. No print is eligible if it has been accepted in any previous CCCC Annual Salon. In all categories, the original image must be made by the competitor. The print may be made by the competitor or be commercially printed.
- 8. Prints should be brought to the competition by 9:30 AM on Saturday, April 17. If you cannot bring your prints at that time, please make special arrangements with the Print Chair, Mary Cattell.

#### Champaign County Camera Club 2010 Salon Rules – *Digital Images Division*

Our Salon has two divisions: digital images and prints. This and the next page contain definitions and other important information about the digital competition. Please read this carefully. If you have questions, please contact Barry Brehm. Please note that dates for submitting information have been given above and will be repeated here.

For purposes of this competition, we are defining what is meant by a **digital image**, and within this broad definition, we are defining what is meant by a **Photo-Realistic digital image**. Please note that five of the seven digital categories are restricted to Photo-Realistic digital images, while any digital image can be placed in the other two categories.

**Definition: Digital Image**: The image must originate as a photograph or photographs made with a digital or film camera. Its final version must be in the jpg digital format. The image must be made by the entrant. **The image must be original and may not incorporate elements produced by anyone else.** 

**Definition:** Photo-Realistic Digital Image: This is a digital image in which the original photographic content predominates. While alteration of the image by the maker is permitted, the alteration should not predominate or be obvious. **Blending of images from different scenes is prohibited**.

CCCC has prepared the following material on the preparation of digital images for the Salon. Please note that the allowed file sizes are unlimited, subject to the number of pixels in the horizontal and vertical directions.

The preferred method of submitting digital images is to provide them to Barry Brehm on a CD or a USB drive. You may bring them to the Club's meeting on April 12; to Barry at his home on Wednesday, April 14 at 7 PM; you may mail your CD to Barry Brehm, 2908 Sierra Drive, Champaign, IL, 61822. You may also e-mail your files to Barry at <a href="mailto:barrybrehm@comcast.net">barrybrehm@comcast.net</a> but make sure your e-mail arrives by Monday, April 12. F our file does not go through it may be necessary to split your images into two or more emails.

The following seven categories for the Salon were approved by the Club in March, 2007. Entries in Categories A through E must meet the definition of Photo-Realistic. Entries for Categories F and G need not be Photo-Realistic, although Photo-Realistic entries are permitted in Categories F and G. Category G is intended for digital images that have been highly manipulated, although such images may be submitted in Category F and any digital image whatsoever can also be submitted in F and G.

A: Landscapes and/or Waterscapes. B: People. C: Fauna. D: Flora. E. Architecture.

F. General. G: Contemporary/Creative.

Definitions of Categories: **A: Landscapes and/or Waterscapes**. Hand of man should appear minimally in these images. **B: People**. Any aspect of human activity featuring one or persons. This category includes portraits of people. **C: Fauna**. Includes both wild and domesticated fauna. **D: Flora**. Includes both wild and domesticated flora. **E. Architecture**. Can be an image showing small architectural details up to a large number of structures, including buildings and bridges and other man-made structures. **F: General**. Anything. **G: Contemporary/Creative**. Images should have a contemporary or creative feeling. This is the primary category for strongly manipulated, very drastically altered digital images, although such images may also be entered in F, General.

**Limits on number of entries:** You may submit up to 4 images for each category, but not more than a total of 21 images.

#### Rules for Sizing and Labeling your images.

Maximum image size is 1024x768 pixels. Size your image so that in the horizontal direction the maximum number of pixels is 1024. In the vertical direction, the maximum number of pixels is 768. For example, an image that is  $1024 \times 740$  is acceptable, but one that is 1024 by 790 is not. The latter would have to be resized so that the vertical is no larger than 768. The file type must be jpg. The color space should be sRGB.

**Filename**: The image file should be labeled as follows: S-I-N-T.jpg where S is the subject category letter (for example A, B, C, D, E, F or G), I is the Image number (starting at 1, and increasing sequentially for the number of images you have entered in the specific category—for this year, I would not exceed 4). N is your Club competition number (for example, 37, 63, 55, 99), and T is the title of the image, where you should have no spaces, use upper case for first letter of each word, lowercase for all other letters (for example, AllertonBark, LamarBridge, ARiverRunsThrough).

Note: each identifier (S, I, N, T) is separated by a hyphen - character. This change is consistent with the manner in which CICCA has clubs and individuals label their digital images, although there are some differences depending on the Salon.

Examples for a final filename for this CCCC Salon would be A-1-37-LuskCreekSunrise.jpg, B-3-37-SpeakerOfTheHouse.jpg, C-2-37-BackyardDewyMonarchButterfly.jpg

When you submit your digital images, please also submit a digital image entry form. This appears on the next page and for your convenience, is also being mailed to you in a separate package as an MS Word document. You can simply type in the information on your computer and e-mail the completed form to Barry Brehm (barrybrehm@comcast.net), to be received by Noon, Wednesday, April 14, or you can print out the form and fill it in by hand and submit it with your CD or USB drive. Clearly, an entry form with typed in information is preferred. This form will be used during the scoring and will be returned to you with your results.

#### **Rules for 2010 I-74 Competition**

- 1. This year's competition will be on May 8 at 7 PM at the Normal First United Methodist Church See earlier in the newsletter for its location in Normal. KodaRoamers is the host club. The topic is Rust and/or Junk.
- 2. Each image should be saved as a jpg image, using the 1024 x 768 sizing method, and should be saved using maximum quality. There is no maximum for the file size.
- 3. An image should be titled as follows: 3-02-32-WaterFlowingThroughAllerton.jpg. This would be the 3rd image (image number 3) in the set of images submitted by the CCCC member with competition number 32. The 02 is CCCC's CICCA club number. The title of the image is Water Flowing Through Allerton (in labeling each new word starts with a cap, no spaces between words--shown here is the more normal way of titling an image). You may submit up to six images for consideration to be selected in the competition and so your initial numbers should be 1 through 6 (assuming you submit 6 images). No member may have more than six images in the competition. Jim Long will eventually renumber our club's 50 images for use in the competition.
- 4. For this competition, a digital image must be Photo-Realistic. This is a digital image in which the original photographic content predominates. Alteration of the image by the maker is permitted, but the alteration should not predominate or be obvious. Blending of images from different scenes is prohibited, e.g., a photo with a white sky cannot have a blue sky from a different photo dropped in.
- 5. Minor edits are allowed. For example, one can modestly use cropping, levels, curves, saturation adjustments, sharpening, contrast, brightness, dust removal, etc. from Photoshop. Sharpening the image is allowed, but over-sharpening will most likely result in an image that fails to look photo realistic. A color photo may be converted to B&W. Cloning is allowed but only to remove minor elements.
- 7. Images from two different scenes cannot be combined to get a new image.
- 8. Blending of images is permissible if the camera remains stationary and records the same scene for each capture. An example for this approach would be capturing a sunset with a high contrast between the background and foreground. By shooting the same scene with different exposures and then blending in properly exposed areas from the appropriate image captures, results can be obtained that are similar to a graduated neutral density filter. This is essentially the technique of using high dynamic range.
- 9. The use of fancy filters, e.g., twirling, spherical coordinates, etc. is not allowed. Application of any filter that results in an unrealistic image is not allowed.
